Introduction

The Client Information Portal ("**CIP**") is a secure website created by the Administrators of Lehman Brothers International (Europe) ("**LBIE**"). The CIP is the 'gateway' for all counterparties to access the sub-portals contained within the CIP (e.g. Client Money Portal, Client Asset Portal, LBIE Creditor Portal, LBIE Affiliates Portal, SSI Portal) (together the "**Site**")

Its purpose is to provide a secure communication channel for LBIE claimants to undertake functions such as viewing indicative statements, filing proofs of debt and providing settlement instructions to the Administrators.

These Guidance Notes have been produced to assist users of the CIP in accessing the Site.



A Primary User is an individual acting on behalf of the Legal Entity, that is or was a client of LBIE, and who is validly appointed to access the Site on behalf of the Legal Entity and who is authorised to enter into certain legal, valid, binding and enforceable obligations with respect the Site, or matters relating to the Site, on behalf of such Legal Entity.

All of the input boxes must be completed. When this is done, you need to click **Certify and Save Details**.



Authorised User Representation

After completing the **Certify Primary User details** page, you will be asked to confirm your agreement to the Authorised User Representations.



If you are a Primary User please tick the appropriate box and you will be provided with the next screen which will ask you to designate the Legal Entity's Administrative User.

If you are a Secondary User when you tick the appropriate box, you will not be able to proceed until a Primary User designates an Administrative User. You will receive a pop-up message to this affect. Please have the Primary User in your Legal Entity log on to and follow the process through to provide access to the CIP for your Legal Entity.



If you are a Primary User, after ticking the appropriate Authorised User representation you will be asked to either 1) complete all fields of information for your designated Administrative User and click to confirm or 2) indicate on the button provided that you, as a Primary User, are also the Administrative User.





Once you, as a Primary User, have designated an Administrative User, LBIE will directly provide the Administrative User with Logon Credentials (i.e. a secure username and password) to access the CIP. The Administrative User will then be able to authorise and provide all Primary Users, Secondary Users, and third party Delegate Users with Logon Credentials to access the Site.



The Joint Administrators act as agents for and on behalf of LBIE and neither they, their firm, members, partners, employees or their representatives shall incur any personal liability whatever under or in relation to this Site or in connection with any information provided on or accessed through this Site.
