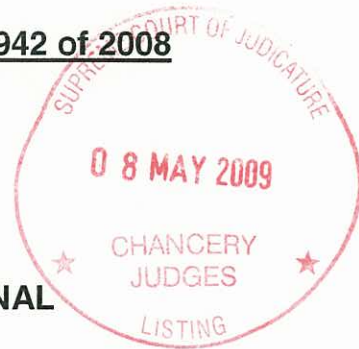

- 3 The Joint Administrators' costs of the Application be paid as an expense of the administration of LBIE.
