### **Phosphorus Holdco Plc - in administration (“the Company”)**

I am writing to inform you that on 1 March 2023, the period of administration was extended to 15 March 2026 by order of the Court.

The administration of the Company was due to come to an end on 15 March 2023. The administrators considered that it was necessary to extend the period of the administration given the timeline of the litigation in Phones 4u Limited, reflecting our belief in the potential continuing value to the creditors of the Company. Given the affairs of the Company and the Phones 4u group of companies are inextricably linked in this regard, we considered it appropriate for the administration of the Company to continue for the same period.

Due to the fact we sought court approval for the previous extensions of the administration, it was necessary for the administrators to apply to the Court again to obtain an order extending the administration of the Company.

Consequently, on 1 March 2023 the Court granted an order extending the administration of the Company through to 15 March 2026. Form AM19 (notice of extension) for the Company has been filed with the Registrar of Companies and a copy is enclosed for your records.
