Statement of reasons

The Joint Administrators believe that the purpose of the administration - to achieve a better result for the Company's creditors than would be the case in the liquidation of the Company - remains reasonably likely to be achieved as the previous extensions and this further one will have provided more time to realise funds due to the Company.

- We are waiting on the final assets' in the bankruptcy estate to be realised and distributed accordingly. We have been advised that Mr Tottman's house is currently on the market, however, to date no offers have been received. The timing of the sale and, therefore, the bankruptcy distribution is currently uncertain.
- If a further distribution is received from the Trustees then the director's loan will be partially repaid and any outstanding amounts written off which will trigger a tax repayment from HMRC.
- To recover any further outstanding tax assets.
- To make a distribution to the Secured Creditors.
- To agree on the most appropriate exit route from administration.
