- 2. A direction that Russell Downs, or failing him any of the other individuals appointed as a joint administrator of the Company, may be appointed chairman of the meetings and that the Company be directed to file with this Court a copy of a report by the chairman of the meetings;
- A direction that, subject to approval by the requisite majority of the Scheme Creditors at the meetings, there may be a further hearing (the "Sanction Hearing") and an order may be made sanctioning the Scheme;
- 4. Directions for the listing of the Sanction Hearing;
- 5. A declaration that Russell Downs is appointed to act as the Company's foreign representative in relation to any petition brought by the Company before the United States Bankruptcy Court for an order recognising the Scheme as a "foreign main proceeding" under Chapter 15 of the U.S. Bankruptcy Code; and
- 6. Such further or other relief as the Court sees fit.

Part 8 of the Civil Procedure Rules 1998 applies to this claim which is made pursuant to CPR Part 49 Practice Direction 49A paragraph 15.

The Claimants will rely on the First Witness Statement of Russell Downs of PricewaterhouseCoopers LLP filed herewith in support of this Claim.
