**NOTICE OF INTENDED DIVIDEND PURSUANT TO RULE 2.95 OF
THE INSOLVENCY RULES 1986**

Notice is hereby given pursuant to Rule 2.95 of the Insolvency Rules 1986 that the Joint Administrators of Lehman Commercial Mortgage Conduit Limited ("LCMC") intend to make a distribution (by way of paying an interim dividend) to the preferential creditors (if any) and to the unsecured, non-preferential creditors of LCMC.

Proofs of debt may be lodged at any point up to (and including) 31 August 2016, the final date for proving claims, however, creditors are requested to lodge their proofs of debt at the earliest possible opportunity.

Persons so proving are required, if so requested, to provide such further details or produce such documents or other evidence as may appear to the Joint Administrators to be necessary.

The Joint Administrators will not be obliged to deal with proofs lodged after the final date for proving but they may do so if they think fit.

The Joint Administrators intend to make such distribution within the period of two months from the final date for proving claims.

Rule 2.95(2)(c) of the Insolvency Rules 1986 requires the Joint Administrators to state in this notice the value of the prescribed part of LCMC's net property which is required to be made available for the satisfaction of LCMC's unsecured debts pursuant to section 176A of the Insolvency Act 1986. There are no floating charges over the assets of LCMC and accordingly, there shall be no prescribed part. All of LCMC's net property will be available for the satisfaction of LCMC's unsecured debts.
