#### Statement of reasons for seeking extension

Consent to extend the period of the administration was sought for the following reasons:

- The initial administration period of 12 months was insufficient for the Joint Administrators to achieve the purpose of the administration, as stated in the Joint Administrators' proposals;
- Asset realisations have not yet been concluded;
- Further time is required to deal with and finalise the Company's tax and VAT affairs; and
- After conclusion of the above matters we must also deal with closure matters including but not limited to obtaining third party clearances, preparation and filing of a final progress report to move the Company to dissolution.
