I'm writing to tell you that the period of the administration has been extended by order of the court by 12 months until 18 October 2022.

I sought this extension to the current period of the administration in order to complete the following outstanding matters:

- VAT and tax compliance: completing the relevant VAT and tax returns, deregistering the company and seeking clearance from HMRC to close the administration;
- Investigation: Ongoing enquiries and consideration of next steps following complex review of activities prior to the Administrators' appointment;
- Statutory and compliance: Dealing with other compliance matters such as progress reports, internal statutory file reviews, final accounts and creditor enquires; and


