Asset realisations have not yet been concluded, including;

- The Company is part of group of retailer claimants pursuing credit card claims related to historical interchange fees imposed on consumer transactions;
- Further time is required to deal with and finalise the Company's tax and VAT affairs; and
- After conclusion of the above matters, we must also deal with closure matters including drafting and issuing the final progress report, closure of our internal systems, and removal of the Administrators' bond.
