This is our report to members and all known creditors following the creditors decision procedure held on 26 May 2023 to consider nominations for the appointment of liquidators to the Companies.

Copies of the directors' report and a summary of the statement of affairs have already been circulated to all known creditors prior to the decision procedure. If for any reason you didn't receive them, please let us know and we'll arrange for further copies to be sent to you. We can also send you details of the Companies' creditors from the statement of affairs if you ask us to.

Resolutions passed by the companies' members

For each of the Companies, the members of the Company separately passed the following written resolution on 26 May 2023:

1. THAT it has been proved to the satisfaction of the undersigned that the Company cannot, by reason of its liabilities, continue its business and accordingly that the Company be wound up voluntarily (by way of a creditors' voluntary liquidation).

2. THAT Rachael Wilkinson of PricewaterhouseCoopers LLP, 3 Forbury Place, 23 Forbury Road, Reading RG1 3JH and Mark James Tobias Banfield of PricewaterhouseCoopers LLP, 7 More London Riverside, London, SE1 2RT be appointed as joint liquidators of the Company for the purpose of its voluntary winding up.

3. THAT any act required or authorised (whether under any enactment or otherwise) to be done by the Liquidators of the Company may be done by any one or more of the persons holding the office of joint liquidator from time to time (whether acting alone or jointly).

The first resolution was a special resolution and the second and third were ordinary resolutions.

Creditors' decision procedure

A creditors decision by deemed consent held to consider nominations for liquidator of Key Food Stores on 25 May 2023 confirmed our appointment and also agreed that anything to be done by the liquidators could be done by either or both of us.

A creditors decision by deemed consent held to consider nominations for liquidator for all the other Companies listed on 26 May 2023 confirmed our appointment and also agreed that anything to be done by the liquidators could be done by either or both of us.

I enclose a copy of form 600 to the Registrar of Companies as formal notice of our appointment in this matter.

Liquidation committee

To date, we haven't received any requests to form a liquidation committee.

What we have to do as liquidators

Where possible, we will realise the Companies' assets and deal with all creditors' claims. We'll investigate the Companies' affairs before they entered liquidation as part of our duties and by law we must consider the directors' conduct and submit our findings to the Department for Business, Energy & Industrial Strategy. If you think there's something we should know about, please tell us as soon as possible.

Estimated dividend prospects

We don't think there will be any dividend for First ranking preferential creditors based on what we know currently because none of the Companies had any employees.

Unsecured creditors

The prescribed part is a fund that has to be made available for unsecured creditors. It's paid out of "net property". Net property is floating charge realisations after costs, and after paying - or setting aside enough to pay - preferential creditors in full. But it only has to be made available where the floating charge was created on or after 15 September 2003.

The amount of the prescribed part is:

50% of net property up to £10,000 20% of net property above £10,000 Subject to a maximum of £600,000 (or £800,000 if the floating charge was created on or after 6 April 2020)

The prescribed part applies to the Companies with the exception of Smile Property Limited, as there are floating charges created after 15 September 2003 registered over their assets. There were no floating charges registered over the assets of Smile Property Limited at the date of the liquidation.

We don't think there will be a dividend for the unsecured creditors under the prescribed part because we don't think the Companies will have any net floating charge realisations. If this is correct, the value of the prescribed part will be £nil for each of the Companies.

We don't think there will be any dividend for unsecured creditors based on what we know currently. The only known potentially realisable assets are intercompany claims against other insolvent entities within the McColls Retail Group Plc group of companies, but it is uncertain to what extent if at all, these would be provable debts in those insolvencies.

Creditors can get VAT bad debt relief six months after their supply but they must have written the debt off. They can receive a dividend on the total amount of their claim, including VAT, but must account to HM Revenue and Customs for the VAT element of the payment. Your local VAT office can help you with this.
