Part B

The Appellant applies for an extension of time of one day for filing the Appellant's Notice.

It had been arranged that the Appellant's Notice would be filed on Friday, 20 January 2017 pursuant to the Order dated 12 December 2016 made by Mr Justice Hildyard. Unfortunately, due to an oversight on the part of the Cleary Gottlieb representative who attended at Court to file the Appellant's Notice, he had taken an incomplete set of documents to Court. Immediately before he left the office for the Court, he had put down the set of appeal papers. When he picked up the papers to travel to Court, he did not notice that certain of the papers, including the Appellant's Notices, had been placed out of sight under a bag. By the time he discovered the mistake, called the office, and the misplaced documents were located, the court fees counter had closed at 4.30 p.m., and Cleary Gottlieb was unable to file the Appellant's Notice on Friday, 20 January 2017.

A copy of the signed Appellant's Notice and all supporting documents were sent to all parties by email on the evening of Friday, 20 January 2017, together with a letter explaining the position and explaining that the Appellant would file the Appellant's Notice on Monday, 23 January 2017.

This Appeal, and the request for an extension of time, is being lodged following the opening of the Court today on Monday, 23 January 2017, being the first opportunity after the error was made to lodge the appeal papers with the court. The Appellant respectfully requests that the Court makes an order extending the time for filing the Appellant's Notice by one day to 23 January 2017.
